Scholarships for Master's and Doctoral Studies in Brazil under the GCUB-Mob International Mobility Programme

The Department of External Resources wishes to inform that the Ministry of Foreign Affairs, Foreign Employment and Tourism, by its letter dated 01 July 2026, has conveyed information received from the Embassy of the Federative Republic of Brazil in Colombo regarding the Fifth Edition of the GCUB-Mob International Mobility Programme, organized by the International Cooperation Group of Brazilian Universities (GCUB). The Programme offers postgraduate study opportunities with scholarships for international students wishing to pursue Master's and Doctoral degrees at Brazilian Universities.

Under this Programme, a total of **889 full scholarships** (539 for Master's degree programmes and 350 for Doctoral degree programmes) are being offered across more than 60 Brazilian universities. It may kindly be noted that no application fee will be charged. Applications are open until **06th July 2026** and may be submitted through the GCUB online portal at <https://www.gcub.org.br>.
